1. Potential

2. Actual

Pecuniary. Kelly obtains financial benefit from the referrals she makes from women seeking AVOs.

3. Potential

Non-pecuniary. Rod does not have a financial interest in his brother's affairs. His interests are social or emotional.

4. Perceived

Non-pecuniary. While the jerseys have a financial value, the value Andrew would obtain through support of this team is social.
